Faculty Council Chair Prof. Jay Simon welcomed everyone and called the meeting to order.

1. Approval of Minutes of December 3, 2024, Meeting

- o Minutes approved.

2. AI Committee Update – Erran Carmel

- Prof. Erran Carmel shared an update from the AI Committee:
 - o Recommendations for Spring 2025:
 - Using AI for student feedback is different from using AI for grading. Be cautious using AI for AIG&F. There are several reasons for this. Perhaps the most important thing is perception.
 - Full disclosure to students prior to task.
 - Use Human-in-the-Loop (Professor-in-the-Loop)
 - Adhere to privacy guidelines
 - KSB should be a thought leader, so if you are an innovator, experiment (with caution) – and then report back to faculty.

- Next policy piece: AI and Deep Research
- The committee has found, as a result of deep research, that a substantial number of your readers in the future will be AI agents. So at Kogod, we must be aware of how we publicize scholarly works. If work is behind a pay wall, it is not available for deep research and therefore is not as impactful as it could be. This will be addressed at the next Kogod meeting.
- AI 2nd Fridays met last week and discussed:
- Impact of AI on copyright infringement, focusing on the legal and ethical issues surrounding the use of copyrighted materials for training AI systems.
- The conversation also touched on the challenges posed by AI tools in the creative industry, the complexities of copyright law, and the concept of publicity rights. conversation ended with a discussion on the differences between replicas and deepfakes, and the need for legislation to address this.

3. Remarks and Updates – Dean David Marchick

- Dean Marchick shared his remarks and updates:
 - Dean Marchick thanked faculty for their hard work on scholarship, teaching, and other activities such as the case competition and recruiting events.
 - The case competition was twice as big as last year. We had 45 teams, 30 judges, and 18 schools.
 - Dean Marchick addressed President Alger’s email and stated that if faculty have any questions, please feel free to contact him (Dean Marchick).
 - Secondly, he addressed Enrollments and Budgets:
 - We have had a significant budget deficit at the university level
 - Our main focus right now is having a good yield for both undergraduate and graduate enrollment for Fall 2025.
 - Our undergraduate numbers are above average, and our applications are up.
 - The graduate level continues to be challenging. We are doing everything we can to create attractive programs for students, but it is a hard market. Our financial situation will depend on yielding a good class, so if Casey or anybody else is asking for help, please help.
 - Although we are in a challenging budget environment, we are still investing:
 - For example, you will hear from Gwanhoo and Nicole later on about new institutes for an AI center and one for sustainability that will be launched with the School of Public Affairs, deepening our investment in these areas.
 - Dates to keep in mind:
 - Tomorrow, we have our Staff awards to celebrate our amazing staff.
 - On March 5, we have a women’s basketball game.
 - On March 27, we are having a second installation of the Kogod Business and Entrepreneurship Hall of Fame.
 - On March 28, we have the installation ceremony for President Alger.

4. Remarks and Updates – Sr. Assoc. Dean Parthiban David

- Sr. Assoc. Dean David shared his remarks and updates:
 - Faculty Planning

- Course gaps
 - We have some VRIP Retirements/resignations coming up. In anticipation of this, we will have to find ways to cover their classes.
 - In addition to this, with the change in undergraduate curriculum, we have two curricula, which is creating an imbalance. To address this, the most immediate need will be covered by: adjuncts, overloads, term/visiting, tenure-line
- HSPL Proposed Change
 - Current Eligibility: term/continuing faculty (PhDs and non-PhDs) who qualify as SA, PA, or SP are eligible
 - those who qualify as IP are ineligible.
 - Proposed change in eligibility: term/continuing faculty (PhDs and non-PhDs) who qualify as SA, PA, SP, or IP are eligible
 - Department chairs will raise these issues in department meetings
- Journal Publications
 - One of the challenges is that published work is always behind a paywall, making it not as easily found. There is a simple alternative approach that we can follow:
 - Most publishers allow authors to share their post-prints. Our current process is that when you have a paper published, you send an email to KSB media so it can be listed in the newsletter. At the same time, if you could also send a postprint of your article, it can be added to the repository so that it is available and accessible.
 - Small step forward as we gear up to enhance visibility and impact given AI
 - Articles will be included in the newsletter after "unconditional" acceptance
- AASCB Planning
 - Dave Harr is our project manager for this exercise. We are piecing together parts of the report every year because it is hard to go back after five years, so we have started a process for this. We are also trying to use existing process, including center directors and so on, based on the annual reports they submit. So some of you may be contacted by Dave Harr for this process.
- Annual Report and Elements
 - April 30th is the deadline for the annual report.
 - Along with CV, narrative, we have also asked for a spreadsheet which lists your papers over the last five years, and it uses a formula to calculate how many points you have earned. However, there is a much easier way to do this by using AI to read off your CV and calculate the points using an algorithm. We will be dispensing instructions on how to do so.

5. AI Institute Update – Prof. Gwanhoo Lee

- Prof. Gwanhoo Lee shared an update on AI Institute:
 - Mission of the AI Institute: To position Kogod as a global leader in AI education and research
 - Goals:
 - Integration of AI into Curricula
 - Innovation in AI Education
 - Guidance on AI Tools
 - Policies/Guidelines for Ethical AI Use
 - Industry Partnerships
 - Promotion of AI Research
 - Collaboration with other AU Units
 - External funding
 - Priorities for Spring 2025:
 - Promoting the adoption of Perplexity Enterprise Pro
 - Training for faculty, students, and staff
 - Champions
 - Faculty AI use in teaching showcase
 - Developing the measures of AI learning outcomes
 - AI for Research Training (2:30-4:30 pm, April 8th)

5. Sustainability Institute Update – Prof. Nicole Darnall

- Prof. Nicole Darnall shared an update on Sustainability Institute:
 - Opportunity:
 - Complex sustainability challenges require systems-based strategies
 - Integrate insights from business, government, and nonprofit
 - **Problem:**
 - Sectors are often siloed, as are the research institutions that study them
 - Outcome? Fragmented, incomplete solutions
 - **Solution:**
 - Sustainability research center focused on enterprise — private business, government, and nonprofits
 - Analyze cross-sector dynamics, identify best practices, and develop data-driven frameworks that organizations can use to implement sustainable strategies effectively
 - Foster collaboration, rigorous research, and knowledge-creation to help enterprises of all types to elevate their sustainability efforts
 - External Landscape: What are others doing?

- 100 U.S. sustainability research centers
- 20 affiliated with a business school and promote research in addition to education and outreach
- 4 emphasize interdisciplinarity – partner with another unit or are university-wide
 - 2 business school and school of sustainability/environment (Michigan, UMass Boston)
 - 2 university-wide (Cornell, UCLA)
- However, no U.S. sustainability center is based on a partnership between a school of business and a school of public affairs.
- Vision of the Sustainability Center:
 - To be a global leader advancing sustainability-driven research and innovative strategies for businesses, governments, and nonprofits globally.
- Plan for the Sustainability Center:
 - **Collaborate** with and **engage** research networks and networks of practice to advance sustainability
 - Produce innovative high-quality **interdisciplinary research** that informs decisions and creates organizational value while addressing complex sustainability problems
 - Emphasize **student development** that focuses on sustainability as core to enterprise success and cultivates the next generation of “sustainability solutioneers”
 - Co-develop local solutions with **global impact** to accelerate and amplify sustainability outcomes
- The strengths that KSB and SPA bring to this space:





- Across AU, we're seeing a whole suite of centers and units that are connecting with sustainability in one way or another. But what we don't see is a center of gravity for sustainability and enterprise research. That is what this center can serve as.
- We have a variety of ongoing conversations here at AU both internally and externally.

- Opportunity areas that build on Kogod and SPA's intellectual strengths and networks:

This new 3-credit course ‘Digital Marketing and Strategy’ will replace the two current offerings and merge them into a single course.
- The longer course will allow for more robust, semester-long, experiential-learning opportunities for students.
